# SMSC Initiation Fee Application

(January 2016 Edition)

The Membership Initiation Fee represents a member's investment in the Club.

A non-refundable initiation fee of \$575 (\$500 plus HST) is required for all new members, **except Social Family and Social Single and Intermediate** (except when the oldest individual is under 30 as of January 1, 2016), and Junior.

## Initiation Fee Details:

- It is non-refundable.
- It is not transferrable: This means it cannot be transferred to another member wishing to join.
- SMSC uses initiation fees to reduce bank debt or to repay earlier bond purchasers who provided money to the club to obtain the building and property that all members enjoy today.

## Payment:

Payment may be made in full at time of application. Alternatively, while a complete initiation fee is required for membership, **payments can be deferred over three years by providing post-dated cheques** for:

- \$172.50 (\$150+HST) dated January 1, 2017
- \$172.50 (\$150+HST) dated January 1, 2018
- \$230.00 (\$200+HST) dated January 1, 2019
